



#### **3251** Basic Chemical Manufacturing

This industry group comprises establishments primarily engaged in manufacturing chemicals using basic processes, such as thermal cracking and distillation. Chemicals manufactured in this industry group are usually separate chemical elements or separate chemically-defined compounds.

### Resin, Synthetic Rubber, and Artificial Synthetic Fibers and Filaments Manufacturing

**32521** Resin and Synthetic Rubber Manufacturing This industry comprises establishments primarily engaged in one or more of the following: (1) manufacturing synthetic resins, plastics materials, and non-vulcanizable elastomers and mixing and blending resins on a custom basis; (2) manufacturing non-customized synthetic resins; and (3) manufacturing synthetic rubber. **32522** Artificial and Synthetic Fibers and Filaments Manufacturing This industry comprises establishments primarily engaged in (1) manufacturing cellulosic (e.g., rayon, acetate) and non-cellulosic (e.g., nylon, polyolefin, polyester) fibers and filaments in the form of monofilament, filament yarn, staple, or tow or (2) manufacturing and texturing cellulosic and non-cellulosic fibers and filaments.

**3255: 32551 Paint and Coating Manufacturing** This industry comprises establishments primarily engaged in (1) mixing pigments, solvents, and binders into paints and other coatings, such as stains, varnishes, lacquers, enamels, shellacs, and water repellant coatings for concrete and masonry, and/or (2) manufacturing allied paint products, such as putties, paint and varnish removers, paint brush cleaners, and frit. **32552 Adhesive Manufacturing** This industry comprises establishments primarily engaged in manufacturing adhesives, glues, and caulking compounds.

### Pesticide, Fertilizer, and Other Agricultural Chemical Manufacturing

**3253: 32531 Fertilizer Manufacturing** – This industry comprises establishments primarily engaged in one or more of the following: (1) manufacturing nitrogenous or phosphatic fertilizer materials; (2) manufacturing fertilizers from sewage or animal waste; (3) manufacturing nitrogenous or phosphatic materials and mixing with other ingredients into fertilizers; and (4) mixing ingredients made elsewhere into fertilizers. **32532 Pesticide & Other Agricultural Chemical Manufacturing** – This industry comprises establishments primarily engaged in the formulation and preparation of agricultural and household pest control chemicals (except fertilizers).






### Development of Alabama's Chemical Industry by Company






## Development of Alabama's Chemical Industry by Employment









## Wage Information Total Wages by Industry








#### 3251 Basic Chemical Manufacturing 2021 Average Annual Employment by Age Group






# 3253 Pesticide, Fertilizer, and Other Agricultural Chemical Manufacturing 2021 Average Annual Employment by Age Group
